## ARTICLES OF ORGANIZATION OF LAKE WORTH PLAZA, L.L.C. a Florida Limited Liability Company (FS 608.407)

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

#### <u>ARTICLE I – NAME</u>


