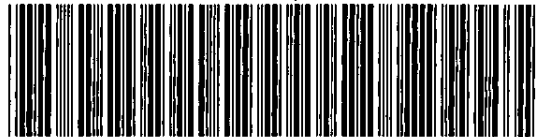



amendment of these articles shall be by a vote of the majority of the members of the Company and as provided in Florida Statute 608.411.

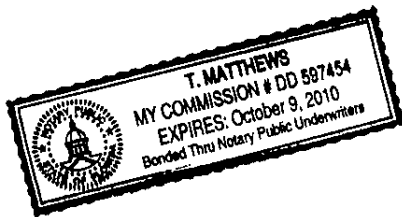
