ARTICLES OF ORGANIZATION OF REPAIRIGHT NETWORK, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

Article I – Name

The name of this limited liability company (the "Company") shall be:

REPAIRIGHT NETWORK, LLC

Article II – Principal Office and Mailing Address

The initial mailing address and initial street address of the principal office of the Company are:

Article III – Registered Office and Registered Agent

Article IV – Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management

or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

Article V – Management of Business

Except for rights that are specifically reserved to the members in the Operating Agreement or these Articles, management of the Company shall be vested in its manager(s). Accordingly, the Company shall be a manager-managed company. Any reference to a member of the Company using the term "managing member" or "member-manager" (or any similar term or title) shall be deemed a reference to such member in the capacity as a manager of the Company, provided that such member otherwise has been duly appointed, designated or elected and otherwise qualifies to serve as a manager.

Article VI – Amendment of Articles of Organization

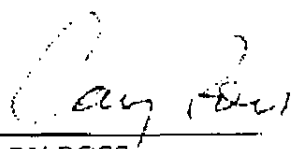
The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.

Article VII – Commencement of Existence

The Company's existence shall commence on and as of November 27, 2007, if the Articles of Organization are filed with and by the Florida Department of State within 10 business days after such date, and otherwise on and as of the date of such filing.
