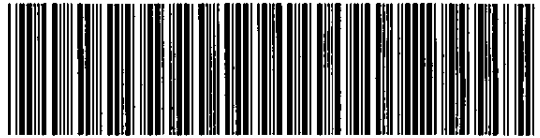

**Article II – Principal Office**


