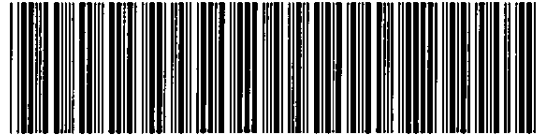

NAME

NEW MEMBERS

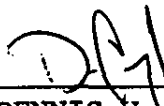

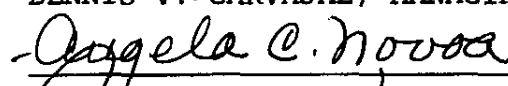
ARTICLE IX

TO CONTINUE BUSINESS

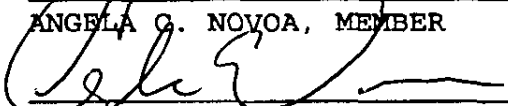
The Company shall be terminated and dissolved upon:

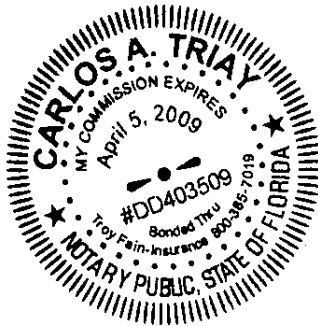
