ARTICLES OF ORGANIZATION
OF

The undersigned, desiring to form a limited liability company under and pursuant to Section 808 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is 30-A RESORTS RENTAL MANAGEMENT, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 170 East Scenic 30A, Santa Rosa Beach, Florida 32459, and its mailing address is 170 East Scenic 30A, Santa Rosa Beach, Florida 32459, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the member(s).
