## ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE 1 - NAME**

The name of the limited liability company shall be FLYING FOX AIR SERVICE LLC ("Company").

#### **ARTICLE 2 - ADDRESS**

#### **ARTICLE 10 - INDEMNIFICATION**

All references in these Articles of Organization are deemed to include any amendment or successor thereto. Nothing contained in these Articles of Organization shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any person who is or was a member, manager. employee or agent of the Company or the ability of the Company otherwise to indemnify or advance expenses to any such person by contract or in any other manner.
