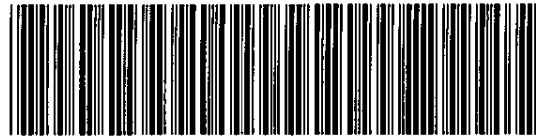

**ARTICLE I
NAME**

The name of this Limited Liability Company is **MANZIL, LLC**.

**ARTICLE II
DURATION**

**ARTICLE III

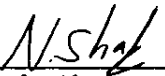
**ARTICLE VI

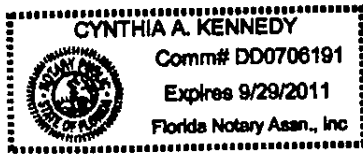

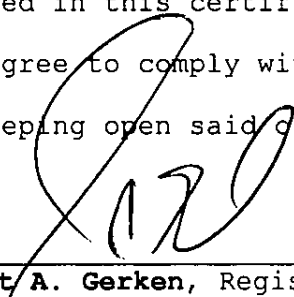
