**ARTICLES OF ORGANIZATION
FOR
AMFLORALS, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of AMFLORALS, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is AMFLORALS, LLC.

**ARTICLE II
