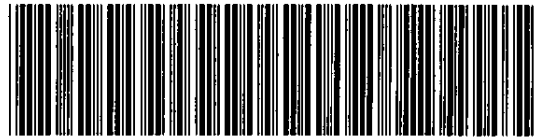



ARTICLES OF ORGANIZATION

OF

7778 56TH STREET N, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **7778 56TH STREET N, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and of the principal office of the Limited Liability Company shall be P.O. Box 1037, Pinellas Park, Florida 33780 and the **STREET ADDRESS** is 6505 96th Avenue N, Pinellas Park, Pinellas County, Florida 33782.

ARTICLE III - DURATION

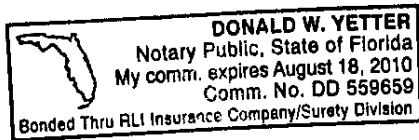



