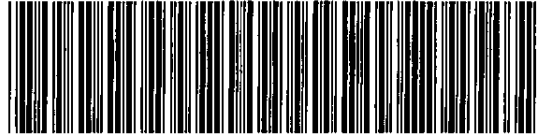



The company may admit additional members at any time and in any manner by the majority written consent of the members.


Article X

Article XI


The company shall have the authority and shall issue Certificates of membership to each member evidencing that member's interest in the company. Certificates of Membership shall be signed by an officer of the company.
