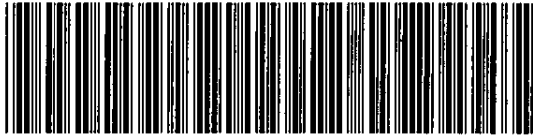

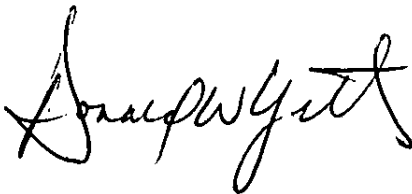

ARTICLES OF ORGANIZATION

OF

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **7009 59TH STREET N, L.L.C.**

ARTICLE II - ADDRESS

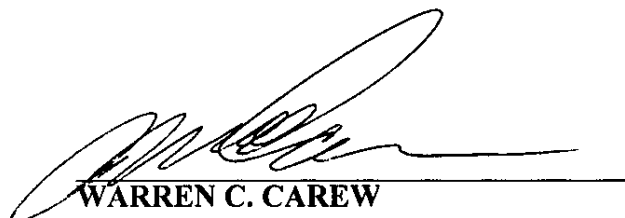

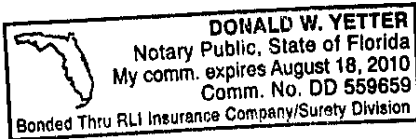
