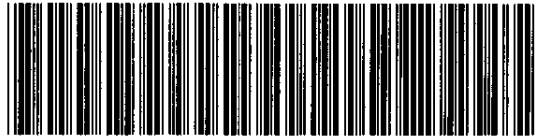



The mailing address and street address of the principal office of the company is 11541 Chesterfield Rd., Dade City, FL 33525.


