

ARTICLES OF ORGANIZATION OF JC Puzzles, LLC



SECRETARY OF STATE KNOW ALL MEN BY THESE PRESENTS: That I/We, Zuo Wang, desiring Abasse Florida form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:
