**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - Name

The name of the limited liability company is ABZ, LLC.

ARTICLE II - Address

The mailing address and the principal office of the limited liability company is:

ARTICLE III - Duration

The period of duration of the limited liability company shall be perpetual.

ARTICLE IV - Purpose

The purpose of this limited liability company is limited exclusively to acquiring qualified indicia of ownership of the real property commonly known as Four Portofino Drive, Unit 1209, Pensacola Beach, Florida 32561 (the "Property") and serving as an exchange accommodation titleholder, as described in Internal Revenue Service Revenue Procedure 2000-37 for the benefit of Ann Hattaway-Zafiroulis and Basile Zafiroulis.

ARTICLE VII - Effective Date




