ARTICLES OF ORGANIZATION

OF

RUMARCAFE, LLC

ARTICLE I

NAME

The name of this limited liability company (the "Company") shall be RUMARCAFE, LLC and its mailing address and principal place of business is 7995 SW 89th St. Miami, Florida 33156.

ARTICLE II

COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles are filed with the Florida Department of State and shall have perpetual existence unless sooner dissolved in accordance with the Regulation of the Company according to law.

ARTICLE III

GENERAL PURPOSE; GENERAL POWERS

ARTICLE V

MANAGEMENT

The Company will be managed by the Managers as set forth in the Regulations adopted by the Company. The name and street address of the Initial Managers are Martha Castaneda-Fernandez 7995 SW 89th St. Miami, Fl. 33156 and Rodolfo Valdes-Castaneda 7995 SW 89th St. Miami, Fl. 33156 who shall serve until either removed by the Members or resignation as provided in the Regulations. The Managers have sole authority to manage the Company and are authorized to make any contracts, enter into any transactions, and make and obtain any commitments of behalf of the Company to conduct or further the Company's business. Except as authorized by the Managers, no Member is an agent of the Company or has the authority to make any contracts, enter into any transactions, or make any commitments on behalf of the Company.

ARTICLE VI

REGULATIONS

The power to adopt, alter amend or repeal the regulations of the Company shall be vested in the Manager.

ARTICLE VII

ADMISSION OF NEW MEMBERS

Additional Members may be admitted from time to time on such terms and conditions as determined by the Managers. No current Member has any preemptive rights.

ARTICLE VIII

DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPLUSION, DISSOLUTION OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Managers may continue the business of the Company without a vote of the Members so long as there is at least one remaining Member of the Company.
