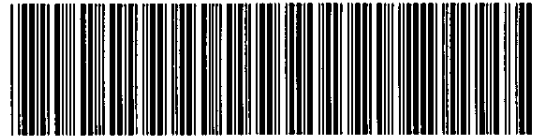



The Limited Liability Company is to be managed by one or more managers appointed by the Members and is, therefore, a manager- managed company.


ARTICLE V- Liability of Members
