MEMBERSHIP



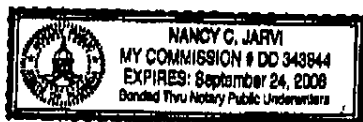
