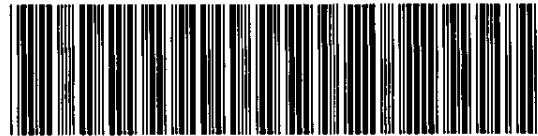

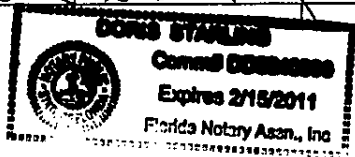

**TO HAVE AND TO HOLD** the same unto the said party of the second part, its administrators and assigns forever.

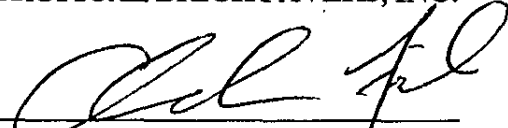

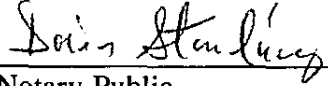
