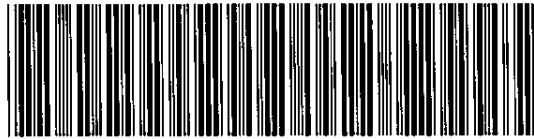

ARTICLE 1 - NAME

ARTICLE 5 - PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in the business of mobile preventive services and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 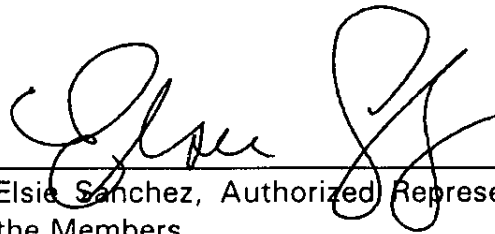

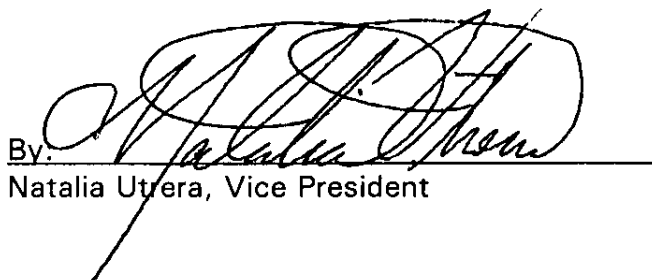
