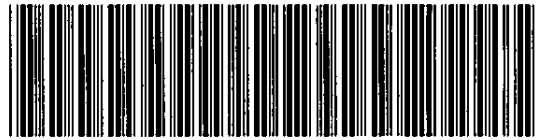

ARTICLES OF ORGANIZATION

MEMBERS' RIGHT TO CONTINUE BUSINESS


