ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be GLOBAL WEB SERVICES INFO, LLC ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 4 - DURATION

ARTICLE 5 - PURPOSES AND POWERS
