ARTICLES OF ORGANIZATION OF CFO COR 001, LLC

ARTICLE I^{*} Name

The name of this limited liability company is CFO COR 001, LLC.

ARTICLE II Existence

This limited liability company shall have perpetual existence.

ARTICLE III Purpose
