OF

- 1. Name. The name of this limited liability company is ANOTHER BLACK DAY, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company's existence shall be effective as of February 20, 2008 and shall thereafter be perpetual.
