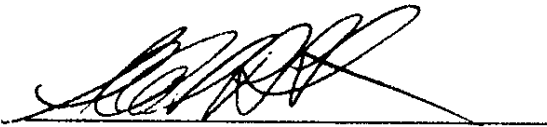

THE UNDERSIGNED hereby executes and swears to these Articles of Correction to Articles of Organization of **ANOTHER BLACK DAY, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.4115:

1. Name of Company. The name of the Company is **ANOTHER BLACK DAY, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization (the "Articles") with the Florida Department of State on February 20, 2008, a copy of which is attached hereto and made a part hereof.
3. Correction to Articles of Organization. Paragraph 6 of the Company's Articles incorrectly reflects that the Company is managed by its members and is hereby corrected to read as follows:

*"6. Management of the Company. The Company shall be managed by one or more managers in accordance with the Operating Agreement adopted by all of the members and is, therefore, a manager-managed company. The initial Manager of the Company shall be **Matthew Wilkof**."*

ARTICLES OF ORGANIZATION
OF
ANOTHER BLACK DAY, LLC

1. Name. The name of this limited liability company is **ANOTHER BLACK DAY, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of February 20, 2008 and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 2907 Bay to Bay Blvd., Suite 314, Tampa, FL 33629.

5. Registered Agent and Office. The name of the initial registered agent of the Company is F&L Corp. The street address of the initial registered agent of the Company is One Independent Drive, Suite 1300, Jacksonville, FL 32202.

6. Management of the Company. The Company shall be managed by its members and is, therefore, a member-managed company. The initial members of the Company are Matthew Wilkof, Angel Hernandez, Jose Robles and Ernesto Paez.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

8. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous agreement of the members, or as otherwise provided in accordance with the Operating Agreement of the Company.

The undersigned executed these Articles of Organization on the 20th day of February, 2008.
