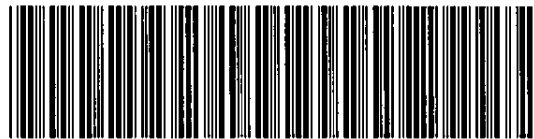


These Articles of Organization may be amended in the manner provided by law.


