The name of the limited liability company is: Silverlakes Property Management, LLC.

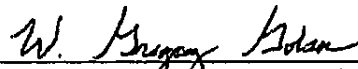
**ARTICLE II. ADDRESS**

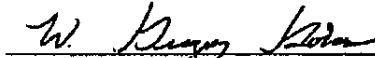
