ARTICLES OF ORGANIZATION OF THOMAS MASTERS & ASSOCIATES, LLC,

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company is **THOMAS MASTERS & ASSOCIATES**. LLC, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall the 4401 Pond Apple Drive South, Naples, Florida 34119-8585.
