**ARTICLES OF ORGANIZATION
OF
WINDSCAPE II ASSOCIATES, LLC**

The undersigned authorized representative hereby executes these Articles of Organization (“**Articles**”) for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the “**Company**”) shall be:

WINDSCAPE II ASSOCIATES, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

Management of Business


Except for rights that are specifically reserved to the members in the Operating Agreement or these Articles, management of the Company shall be vested in its members.


