The name of the Limited Liability Company is **LINVILLE FALLS PROPERTIES, LLC.**



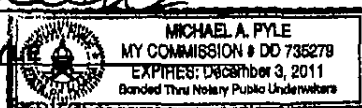


