ARTICLES OF ORGANIZATION OF SAAD SHAIKH, M.D., P.L.

The undersigned natural person, who is licensed and otherwise legally authorized to practice Medicine in the State of Florida, for the purpose of forming a professional limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be Saad Shaikh, M.D., P.L. ("Company").

ARTICLE II

<u>Purpose</u>. The purposes for which the Company is formed are:

- a. To engage in the practice of medicine as a professional limited liability company and to own and operate a medical office for the purposes of providing medical care and treatment.
