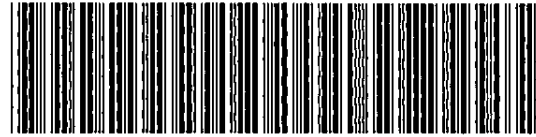

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be DAN NETTUNO, SR., LLC ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 4520 Manatee Ave. W., Bradenton, FL 34209.

ARTICLE III - EXISTENCE AND DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida are Daniel J. Nettuno, Sr., 1502 54th Street W., Bradenton, FL 34209.

ARTICLE V - ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members.

ARTICLE VI - MANAGEMENT

The company shall be managed by the members in accordance with an Operating Agreement adopted by the members for the management of the business and affairs of the company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company

not inconsistent with law or these articles of organization. The names and addresses of the members of the company are set forth hereafter:




