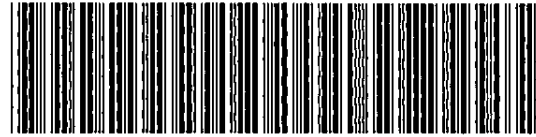

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be DAN NETTUNO, SR., LLC ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 4520 Manatee Ave. W., Bradenton, FL 34209.

ARTICLE III - EXISTENCE AND DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADMISSION OF NEW MEMBERS

not inconsistent with law or these articles of organization. The names and addresses of the members of the company are set forth hereafter:




