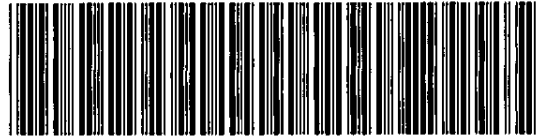

ARTICLE VI - Limitation on Agency Authority of Members

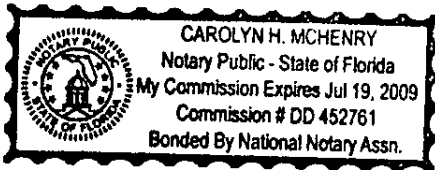
Pursuant to Florida Statutes Section 608.4235, no member of the Company shall be an agent of the Company solely by virtue of being a member.




