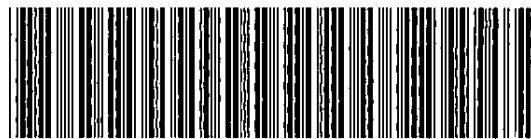

The effective date of the adoption by the members of the above mentioned Amendment was May 6, 2008.


