ARTICLES OF ORGANIZATION
OF
DOCTORCREDITNET, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be DoctorCreditNet, LLC (the "Company").


ARTICLE IV -- REGISTERED OFFICE AND AGENT

IN WITNESS WHEREOF, the undersigned organizer has made and subscribed these Articles of Organization at Naples, Florida, on this 26th day of February, 2008.




