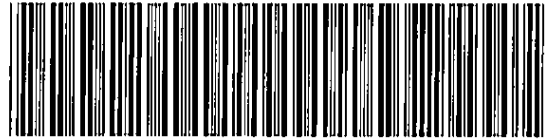

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

ARTICLE IV - MANAGEMENT


The Limited Liability Company is to be managed by one or more Managers having authority and responsibility as allocated in the Operating Agreement. The Managers are as follows:
