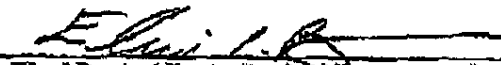
ARTICLE III - MANAGEMENT

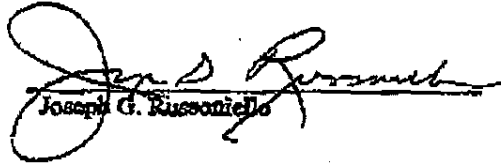
