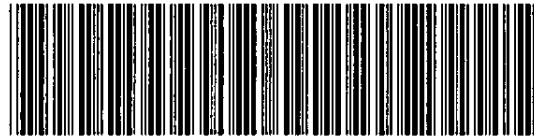

The undersigned, desiring to form a limited liability company, under and pursuant to Chapter 608 of the Florida Statutes, does hereby certify as follows:

ARTICLE I:


