**ARTICLES OF ORGANIZATION
OF
PREMIER CHIROPRACTIC AND WELLNESS CENTER, P.L.C.**

The undersigned member, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be **PREMIER CHIROPRACTIC AND WELLNESS CENTER, P.L.C.** (the "Company").

**ARTICLE II
ADDRESS**

The mailing address of the Company shall be Post Office Box 676, Ponte Vedra Beach, Florida 32004-0676 and the principal office address of the Company shall be 1102 A1A North, Suite 108, Ponte Vedra Beach, Florida 32082.

**ARTICLE III
DURATION**

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided by law.

ADMISSION OF NEW MEMBERS**

A member may transfer his or her interest in the Company as set forth in the operating agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.
