**ARTICLES OF ORGANIZATION
OF
CPT DEVELOPMENT, LLC**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is **CPT DEVELOPMENT, LLC** (the "Company").

The Manager, who shall serve in such capacity until its successor(s) are duly elected and qualified, shall be:

DURATION AND CONTINUATION

PURPOSE


The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
