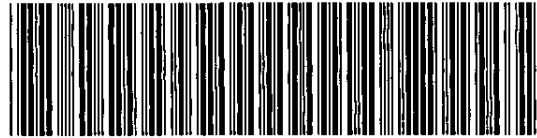

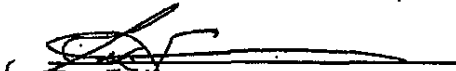

SMR is the sole Member of LAKEWOOD RANCH CORPORATE PARK, LLC at the time of its formation. There are no shareholders having appraisal rights.

5. Conversion Approval. In compliance with Chapter 607, Florida Statutes, and the Bylaws of the Corporation, said conversion was approved in writing by the Board of Directors of the Corporation and by the sole shareholder of the Corporation.

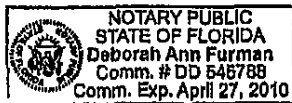

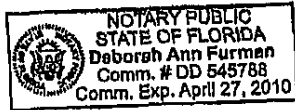
