ARTICLES OF ORGANIZATION OF BLUFF BOULEVARD HOLDINGS, LLC

ARTICLE I Name

The name of this limited liability company is BLUFF BOULEVARD HOLDINGS, LLC.

ARTICLE II Existence

This limited liability company shall have perpetual existence.

ARTICLE III: Purpose

This limited liability company is created for any lawful purpose (except that special statutes for the regulation and control of specific types of businesses shall control when in conflict herewith) and for the benefit of its members and such business as may be agreed on by its members.

- 3. The death, retirement, resignation, expulsion, bankruptcy or dissolution of amendment of this limited liability company, or the occurrence of any other event which terminates the continued

membership of a member in the limited liability company shall not result in the dissolution of this limited liability company. Rather, the remaining members of the limited liability company shall have the right to continue the business of the limited liability company notwithstanding the foregoing events.
