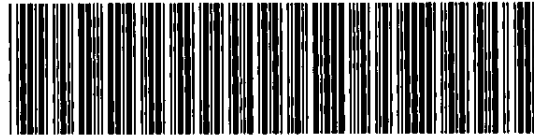

Article IV. Management


The Company shall be managed by the members.


