ARTICLES OF ORGANIZATION FOR CLIP MASTER, LLC

SECRETARY OF STATE

TALLAHASSEE FI DRICA (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

- 1. Name. The name of this company shall be CLIP MASTER, LLC.
- 2. <u>Duration/Continuation</u>. Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.
- 3. <u>Purpose.</u> The purpose for which the Company is organized is to engage in welding and fabrication and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida.
