**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
MARJA J. SPROCK, MD, PLLC**

Pursuant to Section 621.13(3), *Florida Statutes*, and Section 608.441, *Florida Statutes*, Marja J. Sprock, MD, PLLC hereby submits these Articles of Amendment of its Articles of Organization to the Florida Secretary of State to change its business purpose from practicing medicine to any lawful purpose permitted by law and to become subject to the provisions of Chapter 608, *Florida Statutes*.

I. The name of this limited liability company is Marja J. Sprock, MD, PLLC.

II. The Articles of Organization of this limited liability company were filed on February 29, 2008.

III. The Articles of Organization of this limited liability company are amended as follows:

A. Article I of the Articles of Organization are changed to change the name of this limited liability company to Marja J. Sprock, M.D., LLC.

B. Article VI of the Articles of Organization is deleted in its entirety and replaced with the following:

"ARTICLE VI : This limited liability company may engage in any lawful purpose permitted by law."
