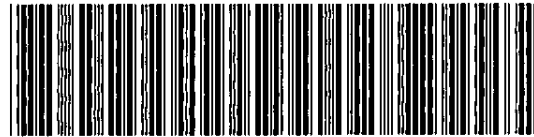

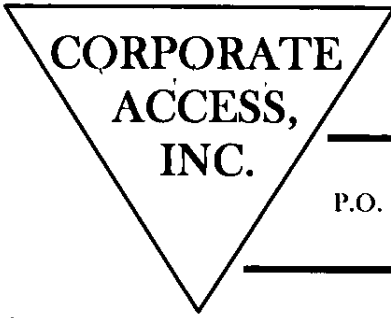

THE UNDERSIGNED, an authorized representative for the purpose of organizing a limited liability company for the transaction of business and the promotion and conduct of the objects and purposes hereinafter stated, under the Florida Limited Liability Company Act, Chapter 608, Florida statutes and do hereby adopt the following Articles of Organization.

**ARTICLE I
NAME**


**ARTICLE VII


