## ARTICLES OF ORGANIZATION

### OF

### PC ACQUISITIONS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

##### NAME

The name of the limited liability company shall be PC Acquisitions, LLC (the "Company"). The mailing of the principal office of the Company in Florida shall be 8641 Baypine Road, Suite 1, Jacksonville, Florida 32256 and the street address of the principal office of the Company in Florida shall be 400 East Bay Street, Jacksonville, Florida 32202.

#### ARTICLE II

##### PURPOSES AND POWERS
