**ARTICLE IV — REGISTERED AGENT AND OFFICE:**

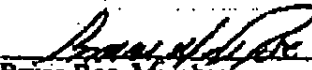

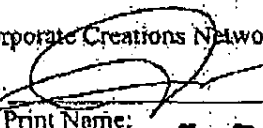
