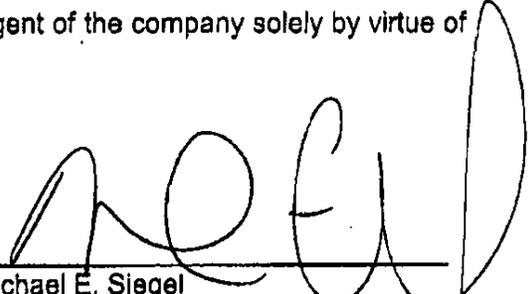
ARTICLE IV - MANAGEMENT
